2006-026 Councillor Charles Fournier moved that the Municipal Council consider the following amendments to the Edmundston (Zone 1) Municipal Plan:

1. Changing land use from Sport and playground to Commercial and Institutionnal, the land owned by Edmundston., located on Hebert boulevard in Edmundston, N.B., PID# 35142942, 35171545 and 35171842.
