 Changing land use from Residential low density to medium and high density, the land owned by <u>RPB</u> <u>Construction Ltd</u>, located on Perron street in Edmundston, N.B., PID# 35329762. 2. Changing land use from Residential low density to Highway commercial, the land owned by Jean C. Dupont Ltée, located on Canada road in Edmundston, N. B. PID # 35266782.

BE IT THEREFORE RESOLVED THAT that this moved amendments be presented to the public on June 12, 2006, in the Edmundston council chambers at 8 p.m., and that the Clerk be responsible, on behalf of and for the interest of the Council, for advertising the public notice prescribed in section 25 of the Community Planning Act in Le Madawaska newspaper, indicating the Council's intention, the date and the location of the public presentation, and that oppositions and comments to the moved project may be presented to the Council within thirty (30) days of the public presentation date by sending them to the Director of the Municipal Planning Commission.
