**AMENDMENT TO EDMUNDSTON (ZONE 1) ZONING BY-LAW

Changing land use the property owned by Edmundston, located on Gouverneurs street in Edmundston, N.B., PID# 35235506 and 35310739 from Residential single and two family dwelling (R2) and Multiple dwellings (R4) to Residential multiple dwelling (R4) zone.
