FAMNB – LEGISLATIVE RENEWAL

2014 -059 BE IT RESOLVED THAT the municipality of Edmundston request the provincial government to reiterate its commitment to the modernization of the municipal legislative priority and work together with municipalities to establish a genuine permissive legislative framework which will recognize municipalities as an order of government and empower all municipalities to meet current and future needs of their citizens.

BE IT RESOLVED THAT the municipality of Edmundston request the provincial government to establish a timetable for the next steps and determine a new deadline to see the adoption of a new municipal legislative framework.

BE IT RESOLVED THAT this motion be forwarded to the Minister of the Environment and Local Government, the Premier of New Brunswick and president of the Francophone Association of Municipalities of New Brunswick.

Seconded by Gerald Morneau. Carried


