Part 2 Bidder Guidelines

2.1 To allow for a rigorous and fair evaluation of proposals, all bidders must ensure that their submission includes the following information:

1. Company Experience

Provide examples of similar completed projects, including work description, area, materials used, and project duration.

Mention specific experience in sandblasting and painting pools or concrete surfaces.

2. Proposed Methodology

Detail the surface preparation steps, environmental protection measures, and residue management.

Provide a clear and structured work plan.

Describe the equipment and techniques to be used for sandblasting and painting.

3. Quality of Products

Identify the paint products to be used (epoxy, urethane, etc.) and provide technical data sheets.

Confirm that products meet current environmental and safety standards.

Indicate application methods and drying times between coats.

4. Work Schedule

Provide a realistic project schedule, including mobilization, preparation, painting, and cleanup phases.

Mention planned measures to avoid unjustified delays.

5. References and Certifications

Provide at least four client references for similar projects.

Include the company's professional certifications and proof of liability insurance.

6. Mobilization and Organization

Describe the planned human and material resources for the site.

Include safety measures for staff (e.g., personal protective equipment).

Mention the logistics for equipment setup and teardown.
