3. In the Drawings Number 2407686-2D-C01, in the general notes, please replace the sentence 28 with the following:

CONTRACTOR WILL BE RESPONSIBLE FOR THE SUPPLY AND INSTALLATION OF TOPSOIL AND HYDROSEEDING FOLLOWING THE CURBS AND GUTTERS INSTALLATION. ~~THE RETAINING WALLS AND~~ **ASPHALT** DRIVEWAYS RE-INSTATEMENTS WILL BE BY THE CITY OF EDMUNDSTON.

4. In the Drawings Number 2407686-2D-C02, in the notes on the right side, please replace the sentence 3 with the following:
